The work programme 2024¹ will contribute towards further development of a European Health Union.

It will particularly address:

- ▶ Europe's Beating Cancer Plan
- ▶ Cross-border health threats
- ▶ Health-related urgencies due to Russia's war against Ukraine
- ▶ Digital health transition
- ▶ Pharmaceutical Strategy for Europe
- ▶ Health promotion and disease prevention including mental health
- ▶ Health systems and healthcare workforce
- ▶ Global Health and international initiatives
